These bylaws are very time demanding and problematic for the people affected by them. Example: The City of Cornwall issues an order for everyone to get rid of their pigeons within 30 days.

We understand members are leaving the CRPU for the AU and IF. We ask, if you are suddenly faced with an order to get rid of your birds will those organizations come to the table and meet with Council to help you? We need solidarity in the racing pigeon sport now more than ever. If you are considering leaving or you know someone who has please re-consider. If the CRPU has made errors tell us what the issue is and what the solution is. We keep hearing the CRPU tells us to do this and that. That is not true. The constitution was rewritten for you. Clubs are Municipal Government, Combines are the Provincial Governments and the CRPU is the Federal Government. The CRPU provides guidance and our rules only apply to our Awards Program.

Clubs have to get politically involved. You must know your local politicians and work with them to address problems before they become major issues.
